2. **Overall discount rate** must be quoted with **at least 20%** discount on all books

3. The Supply Order will be placed considering the reasonable flat discount offer given by Bidder for maximum number of books in the list.
4. The Bidder is bound to supply the books for which the quote has been put.
5. The **latest edition of book shall be supplied** unless specified by the Institute.
6. Rate shall be inclusive of cost of packing, forwarding including delivery of books at ICAR- CIRCOT Matunga, Mumbai.
7. The books available in dual foreign currencies shall be quoted in the currency by which the converted cost is the lowest in Indian rupees.
8. The books shall be consigned by Speed Post Parcel/Registered Parcel/Courier/Person at ICAR- CIRCOT Matunga, Mumbai.
9. Quotation validity less than 90 days shall not be accepted.
10. The delivery period for Indian Publications is maximum **20 days** and for Foreign Publications is maximum **45 days** from the date of issue of the purchase order. If the Supplier requests for an extension citing valid reasons, then delivery date can be extended by this Institute at its discretion.
11. Supply of books beyond the stipulated date of delivery (including the extension granted, if any) shall lead to a **1% penalty of the listed price on the supplier per week maximum up to two weeks; beyond which the order shall stand cancelled**.
12. The suppliers shall replace **free of charge** any defective book for faulty printing/pagination and soiled copy, or broken CDROM supplied along with the book if any; or any other reason whatsoever and full payment shall be kept on hold till supply of fresh book/CDROM.
13. No Advance shall be paid in any case.
14. Pre-receipted bills are to be submitted in triplicate (3 copies) after the entire supply against purchase order issued by ICAR-CIRCOT.
15. **Invoice/bill shall be put up in Indian rupees only.**
16. Reserve Bank of India (RBI)/ Nationalized Bank Exchange selling rates as applicable on the date of invoice for books only be allowed and let it be clearly indicated on the invoice.
17. **The Good Offices Committee (GOC) rates will not be allowed for exchange rate as GOC is not a Government entity.**
