- iii) The interested candidates have to appear for the walk in interview on the scheduled date and time along with application, bio-data and attested copies and original documents related to age, qualifications, experience etc. for verification.
- iv) All eligible candidates should be present 30 minutes before the scheduled time on the date of interview for necessary formalities.
- v) The candidates has to submit no objection certificate from the employer in case he / she is employed elsewhere.
- vi) The candidates should possess 1st class or 60% marks or equivalent overall CGPA.
- vii) No separate interview call letter will be issued to candidates.
- viii) Candidates attending walk in interview should ensure they fulfil all eligibility conditions.
