In pursuance to DARE's letter no. J-24/3/2023-IC-CG-Part(1) (e-279651), dated 13th October,2023 Mr. Himanshu Shekhar Chaurasia, Scientist ICAR-CIRCOT, Mumbai is relieved from 15th October,2023 (F.N.) for participation in the 6th International Rice Congress and associate event during 16-19 October, 2023 being organized by International Rice Research Institute (IRRI), Philippines subject to no financial obligation on the part of DARE/ICAR/Institutes.

The instant visit will be treated as "Official Visit". The deputation will commence from the date of his departure from the Headquarters and would end on the date of their arrival in India.

The period of his absence while on deputation abroad will be treated as duty and during the period of his deputation he will be entitled to draw full pay and allowances which he would have drawn but for dis deputation abroad in accordance with FR 51. He will draw salary for the period of deputation in Indian Rupees.

The entire period of his deputation would count for increment in the time scale of the post held by him before his deputation abroad and also for promotion and pension.

The post held by him is not to be filled during the period of his deputation abroad and arrangement would be made to carry out the current duties of his post without any extra expenditure.

The host institute, which is organizing the conference is funding 50% of the registration fee and rest is being self-funded. Additional expenses incurred will be entirely born by the applicant. There is no financial liability on the part of DARE/ICAR.

Mr. Himanshu Shekhar Chaurasia, Scientist shall submit the deputation report on FVMS portal of ICAR within one month of his return from abroad indicating actionable points of DARE/ICAR with a copy to Subject Matter Division for follow up of the action points.
