- 2. An EMD of Rs. 25000/- (Twenty Five Thousand Only) by cash or DD in favour of "DIRECTOR, CIRCOT, MUMBAI" needs to be deposited in our institute on 12.10.2022 between 10.00 am to 5.00 pm. Without EMD, bidder will not be allowed to participate in Open Auction on next day. You can quote your Bid in Open Auction at 11:00 AM on 13/10/2022 on the spot in our Institute.
- Bidder quoting highest amount after open auction shall be declared as successful bidder. (No further correspondence will be entertained by the Institute. In case of failure to accept the same or lift the material on same day, the EMD amount will be forfeited).
- 4. CGST 2.5% & SGST 2.5% (GST of 5%) will be applicable on the bidding amount which will be borne by the successfully bidder.

- 5. The bid amount has to be deposited by DD/Debit/Credit card/ only immediately on acceptance of the Bid. The entire material should be removed and lifted by the Bidder immediately and the place should be cleaned up to 05:00 PM.,same day.
- 6. If it is found that bidder is not following the terms and conditions of payment/delivery or other conditions of the auction and also indulging in any malpractices either himself or by his agents, deputies or observes, such bidder is liable to be blacklisted and appropriate action will be taken as per Govt of India rules and regulations and E.M.D. of Rs. 25000/- (Rupees Twenty Five Thousand only) deposited by them will be forfeited.
