INSTRUCTIONS TO BIDDERS, TERMS & CONDITIONS OF CONTRACT FOR EXECUTION OF WORKS.

1. The Director, ICAR-CIRCOT, Matunga, Mumbai., inviting online tenders from the MCGM approved Structural auditors or from Govt. Registered Contractors for the above work. Interested agencies shall submit their tenders online on Central Publicprocurement portal site (CPPP Site: <https://eprocure.gov.in>) with in Last date for receiving Tenders.

2. Technical documents & BOQ like, 1) Scanned copy of Mumbai corporation of Greater Mumbai (MCGM) Structuralauditor approval letter or Scan copy of Govt. depts. Registration/License/Empanelled list 2) Scan copy of GST document 3) Scan copy of Pan card 4) Scan copy of duly filled Performa for Exemption of EMD 5) Letter of undertaking of Annexure-II and 6) Bill of Quantity (BOQ) to be filled and uploaded on website.

3. Validity of Tenders will be 3 Months and Time limit for completion of work is 60 days.

4. The Defect liability Period is 365 days. Any defect arising during the defect liability period is to be rectified by the Contractor without any cost, failing which the same shall be carried out departmentally at the "risk or cost" of the contractor and the amount of expenditure shall be deducted from the security deposit.

5. The work must be completed before prescribed time, failing which a penalty @ 1.5% of the tendered amount per month of delay to be computed on per day basis will be charged.

6. The Quoted rate should be inclusive of cost material, labour charges, carriages, all taxes whatsoever, storage, watch and ward, wastages etc. The quoted rate shall not be increased under any circumstances.

8. The Job is to be executed strictly in a professional manner as per the prevailing specifications mentioned in Bureau of Indian Standards (BIS).
9. The Quantity may be increased or decreased at the time of execution of Job. Rates quoted by the bidders will remain same for such quantities.

11. Income tax will be deducted at source from the bill as per rules.
