- 2. Lint samples have been drawn professionally by selecting and professionally cutting one random bale each from lots of 25 bales for analysing the lint quality parameters. The mean value of fibre quality parameter of the bales is given as below.

- 3. The interested parties may collect ½ kg sample from each bale already selected for sampling to ensure the quality of bales.
- 4. The mean fibre quality parameters of the bales mentioned in this bid document is only indicative to assist buyers in offering prices. ICAR-CIRCOT is not responsible for any deviation in the lint quality parameters. The buyers need to inspect the quality of bales

themselves before bidding. No quality dispute of any nature will be entertained, once the sale is concluded. The sale of bales will be purely on "as is where is basis".

- An EMD of Rs. 50000/- (Fifty thousand only) is required to be submitted along with sealed quotations in the form of DD of Nationalized bank in favour of Director, ICAR- CIRCOT, Mumbai.
- 6. Quotation without EMD will be rejected.

- 10. A cheque of Rs. 40 lakh is to be deposited in favour of **Office in charge GTC**, **Nagpur** by the successful bidder as security before weighment of bales. The same will be returned after credit of full bale prices into our bank account.
