These two envelopes shall be put in one bigger (outer) envelope and sealed. The Sealed outer envelope shall be superscripted "Purchase of Cotton Stalk Chipper" due date 01.03.2024" and may be send by registered post, speed post, courier or hand delivery so as to reach this Institute on or before 01.03.2024 at 3.00 PM. The same will be opened by the Local Purchase Committee constituted by the competent authority in this Institute. The tender without above superscription on the cover will be not be considered. The tender received after due date and time will not be accepted.

The purchase shall be governed by the following terms and conditions:

- 1. Rates of GST as applicable, any other charges etc. if any may be shown separately in Annexure-III (format for quotation) failing which it will be assumed that the quoted rates is inclusive of all Taxes and any additional amount demanded on any account later on will not be entertained and on this account shall not be paid.
- Rate must be quoted FOR destination at Ginning Training Centre ICAR-Central Institute for Research on Cotton Technology (Indian Council of Agricultural Research), Amaravati Road. Post Wadi, Nagpur- 440 023

- 3. The GST as applicable if any stipulated by the supplier in their quotation should be paid first by the supplier which should be claim in their invoice along with receipt on account of payment of GST for reimbursement from the purchaser. The payment of demurrage charges if any for non-payment of GST etc. shall be the responsibility of supplier and not that of the purchaser.
- 4. TDS and statutory taxes will be deducted as applicable.
- 5. The firm submitting tender must have valid GST Registration No./PAN No. etc. and copy of the same to be enclosed with their tender (To be submitted in Technical Bid) failing which their bid shall be treated as non-responsive and rejected.
- 6. The bidder shall be from OEM (Original Equipment Manufacturer) only and have supplied at least 5 such items during the last year.
- 7. The vendor should clearly spell out the offered as per ANNEXURE-II. The vendor will have to submit TECHNICAL COMPLIANCE STATEMENT as per ANNEXURE-II, FINANCIAL BID as per ANNEXURE-III, and EMD, MSME/NSIC Certificate, GST Certificate & No./PAN No. etc. as per ANNEXURE -IV failing which the BID shall be REJECTED. - 8. Onsite Guarantee/Warranty for minimum one year should be provided for all the items quoted.
- 9. "Catalogue/Brochure pertaining to the make and model of the product needs to be attached".
- 10. Only Technical bid will be opened first and after evaluation of Technical bids, only technically qualified bids as per evaluation/compliance/responsive statements and recommendations of the purchase committee will be taken in to consideration for opening their respective financial bids at a convenient date.
- 11. Rate and quantity for all required consumables spares and essential accessories should be quoted separately.
- 12. Tender should remain valid for 90 days and validity less than 90 days shall not be accepted and treated a non-responsive.
- 13. Liquidated Damages for delayed supplied @0.5% per week of the contract value will be charged. Maximum L.D shall not be more than 10% of C.V
- 14. EMD of Rs.80,000/- (Rupees Seventy Five Thousand Only) must be deposited with bid/quotation in form of Demand draft/Banker's cheque/Pay order issued from scheduled Bank and payable to "Director ICAR-CIRCOT, Mumbai "failing which their offer will not be considered. The EMD of the unsuccessful bidder shall be refunded without any interest after award of the contract. The EMD of the successfully bidder shall be refunded after receipt S.D
